

COOKIE STATEMENT

This Cookie Statement explains how Miller Industries, Inc. and all our direct and indirect subsidiaries and affiliates (collectively “Miller Industries”, “we”, “our”, and “us”) use cookies and similar technologies to recognize you when you visit <https://www.millerind.com/> (the “Website”). It explains what these technologies are and why we use them, as well as your rights to control our use of them.

What are cookies?

Cookies are small data files that are placed on your computer or mobile device when you visit a website. Cookies are widely used by website owners in order to make their websites work, or to work more efficiently, as well as to provide reporting information.

Cookies set by the website owner (in this case, Miller Industries) are called “first party cookies”. Cookies set by parties other than the website owner are called “third party cookies”. Third party cookies enable third party features or functionality to be provided on or through the website (e.g., advertising, interactive content and analytics). The parties that set these third party cookies can recognize your computer both when it visits the website in question and also when it visits certain other websites.

Why do we use cookies?

We use first party and third-party cookies for several reasons. Some cookies are required for technical reasons in order for our Website to operate, and we refer to these as “essential” or “strictly necessary” cookies. Other cookies also enable us to track and target the interests of our users to enhance the experience on our Website. Third parties serve cookies through our Website for analytics. This is described in more detail below.

The specific types of first and third-party cookies served through our Website and the purposes they perform are described in the table below:

Essential website cookies: These cookies are strictly necessary to provide you with services available through our Website.
